

### ***TruWest® Credit Union Pima County New Member Giveaway (“Promotion”) Official Rules***

*Between May 15, 2017, and July 31, 2017, Pima County residents who 1) become a member of TruWest® Credit Union by joining online or at a TruWest branch location, and 2) Set up a checking account with direct deposit, will receive \$250 and be entered for a chance to win a \$2,500 Visa gift card (“Prize”).*

**Eligibility for Promotion.** Promotion period begins on May 15, 2017 and ends July 31, 2017. Must be a TruWest member with a minimum of \$5 deposit. Must have a TruWest checking account with \$500 aggregate in direct deposits effective within 60 days after opening account. \$250 will be deposited into new member’s checking account within 60 days of account opening AND after first direct deposit. If member does not have an initiated direct deposit within 60 days of account opening, member is ineligible for the Promotion.

Automatic entry into the promotion and eligibility for the Prize is based upon becoming a member of TruWest Credit Union at [www.truWest.org](http://www.truWest.org), or at a TruWest branch location. Each membership will count as ten (10) entries into the \$2,500 Prize giveaway. All other entries will be entered in the drawing upon receipt of a written entry on a 3 x 5 piece of paper referencing the “TruWest Pima County Giveaway” and setting forth the entrant’s name, address, telephone number, and member number, mailed to TruWest Credit Union, “Pima County New Member Giveaway,” PO Box 3489, Scottsdale, AZ 85271, and postmarked by July 31, 2017. One entry per person; no photocopied or mechanically reproduced entries accepted. The Credit Union is not responsible for lost, late, misdelivered, incomplete or postage due entries. All form submissions receive one (1) entry into the giveaway.

All persons must be 18 years of age or older, and U.S. residents in Pima County, Arizona. Employees of the Credit Union and their immediate family members residing in a single household are not eligible. No purchase is necessary. Subject to change without notice.

**Prize.** The Credit Union will award one (1) Visa \$2,500 gift card to a selected winner, who will be selected in a random drawing to be held from among the eligible entrants received, and the selection will be final. However, if a prize is unclaimed or if a winner is deemed ineligible for any reason, the Credit Union may, at its discretion, choose an alternate winner by the same method, until each prize is awarded in accordance with these rules. Drawing will be held from August 1 – August 15, 2017. Winner will be notified by email or phone. By submitting any entry you agree to be bound by these official rules, and prizes will be awarded only if entrants comply. To claim a prize, winner must sign and return a release, affidavit of eligibility and a publicity release to the Credit Union at 1667 North Priest Drive, Tempe, AZ 85281, within 30 days of notification, or prize will, in the Credit Union’s discretion, be forfeited. No other consideration will be paid and winner is responsible for any applicable taxes or other expenses related to any prize awarded. By accepting a prize, a winner consents to the use of his/her name and photograph or likeness for advertising and promotional services without additional compensation. If applicable, the drawing will be made among the eligible entrants for the prize with the highest dollar value first; and thereafter, the drawing will continue from the highest value award to the smallest, until all prizes are awarded pursuant to these official rules. Void where prohibited by law. All federal, state and local laws and regulations apply.

**Release of Claims:** All winners, members of any winners’ household, relatives and persons who use any prize awarded by Credit Union, and such persons, heirs, assigns, executors and administrators release and exempt Credit Union and its directors, officers, employees and agents from any and all claims, actions, demands, chooses in action and damages which they have now or any time in the future arising from use of any prize, including personal injury or death.
